Company Profile

Vedior is the third largest global staffing services provider in the world, based on sales of €6.7 million in 2001. With a network of over 2,300 offices in 29 countries spanning Europe, North America, Australasia, Asia, South America, and Africa, Vedior offers a broad range of staffing services including temporary staffing, permanent placement and other employment-related services. Temporary staffing accounted for approximately 96% of its sales in 2001.

The company offers staffing services in both specialist and traditional sectors. Specialist staffing services include the provision of professional and skilled workers through its established international brands - such as Sapphire Technologies, Expectra and Teleresources - and a wide variety of strong regional and local brands. These services accounted for 31% of sales and 44% of operating income (before goodwill amortisation) in 2001. Traditional staffing services include the provision of office administration and light industrial workers primarily through the Vedior and VediorBis brands. Traditional staffing accounted for 69% of sales and 56% of operating income (before goodwill amortisation) in 2001.
